<p>1. Passport or other travel document and one copy of the identification page. Travel document must be valid at least 90 days after the expiration of visa and not older than 10 years. Travel document must have at least two consecutive blank pages. Damaged travel documents cannot be accepted.</p> <p>护照或其他有效旅行文件及一份护照身份页的复印件。 护照应为在过去 10 年内签发，且在要签发的签证有效期后仍有至少 90 天的有效时间。 护照应有至少两页连续的空白页，损坏护照将不予受理。</p>			

2.	<p>Fill out one Visa Application Form per applicant, available online only at:  <a href="https://epak.pmlp.gov.lv/NVIS.EService001.WebSite/ApplicationMain.aspx">https://epak.pmlp.gov.lv/NVIS.EService001.WebSite/ApplicationMain.aspx</a>.  Print and sign the Visa Application Form (if minor, signed by either parents or legal guardians), accompanied by one color photograph with the following specifications: passport type, light color background, 45mm ×35mm, dating from the last 6 months.</p> <p>Note: 2 signatures (3 for MULT visa applications) per applicant are required on the fifth page of printed visa application (top and bottom)</p> <p>每人填写在线签证申请表，网址为：  <a href="https://epak.pmlp.gov.lv/NVIS.EService001.WebSite/ApplicationMain.aspx">https://epak.pmlp.gov.lv/NVIS.EService001.WebSite/ApplicationMain.aspx</a>。打印并且签署签证申请表（未满 18 岁的申请人须由双方父母或法定监护人签字），以及一张护照照片尺寸的彩照，照片需为浅色背景，35x45 毫米，并需为最近六个月内所照。</p> <p>注明：申请人需要在签证申请表第五页顶部一栏和底部一栏签名，申请多次入境的申请人需要在签证申请表第五页第一、二和最后一栏签名。</p>			
3.	<p>Travel medical insurance, original or one copy of the certificate. Handwritten certificates will not be accepted. The name of the insured should be written also in pinyin. Travel insurance must be valid in the Schengen area and for the entire duration of stay in the Schengen area. The insurance must have minimum coverage of 30.000 euro and cover costs of any emergency medical treatment and repatriation for medical reasons as well as in case of death repatriation of the deceased.</p> <p>For single entry visa, a signed declaration of insurance should be enclosed. 5.	<p><b>Minors travelling alone or with one parent:</b></p> <ul style="list-style-type: none"> <li>- Notary Certificate of permission to travel from both parents or legal guardians and legalized by MFA, and when not in China, attested by the relevant authorities in the country of residence.</li> </ul> <p>未成年人单独旅行或者和单方家长旅行时：</p> <p>— 由双方家长或法定监护人出具的出行同意书的公证书，并由外交部认证；在中国境外办理时，由境外相关政府机构办理该公证。</p>			
6.	<p>Original “Hukou” with photocopies of all the pages (only for Chinese nationals).</p> <p>户口本原件及户口本所有页的复印件（只针对中国公民）</p>			
7.	<p>ID Copy (Original and photocopy)</p> <p>身份证复印件（原件及复印件）</p>			
8.	<p>1) Proof of accommodation: For the whole duration of the intended stay.</p> <p>Notes: documents must cover the whole stay in Schengen area. 9.	<p>Travel programme (itinerary).</p> <p>Notes: documents providing clear evidences about the applicant's travel programme in Latvia and in Schengen area. 10.	<p>Proof of solvency of the applicant: Bank statements from the last 3 months <u>or Zhima Visa Report (Zhima score should be equal to or greater than 700)</u>, no deposits.</p> <p>申请人偿付能力证明：最近 3 个月的银行对账单<u>或芝麻签证报告(芝麻分数需 700 分或以上)</u>，无需存款证明。</p>			
11.	<p><b>For Employees:</b>  A sealed copy of the business license of the employing company;  A letter from the employer (in English, or in Chinese with English translation) on official company paper with stamp, signature, date and clearly mentioning:  -Address, telephone and fax numbers of the employing company  -The name and position in the employing company of the countersigning officer  -The name of the applicant, position, salary and years of service  -Approval for leave or absence</p> <p><b>For Retired persons:</b>  Proof of pension or other regular income</p> <p><b>For Unemployed adults:</b>  If married: Letter of employment and income of the spouse + Notary certificate of marriage, legalised by MFA.
